ACKNOWLEDGMENT OF POLICIES ADDENDUM

I/We understand that being part of the Pewaukee Lake Water Ski Club (PLWSC) is a privilege and not a right. Pewaukee Lake Water Ski Club (PLWSC) is organized as a 501(c) (3) volunteer charitable organization operated exclusively for educational purposes to strengthen the skills of its members by providing show ski instruction and sponsoring and performing water ski shows for the community. By signing the Membership Application, I/we acknowledge and agree to the following:

1. Dedicated volunteers are required to run our club and it is important that all members contribute their time and talents to the common good of the club. As such each member family is asked to participate in at least one of the vital functions necessary to run our organization by signing up for and participating in one of the following committees: Boat Team, Club Events, Program Booklet, Learn to Ski, Costumes, Marketing & Public Relations, Membership, Fundraising, Sound, Special Events, Waterfront Festival, Safety, Boat/Trailer Maintenance & Repair, Facilities, or Ski Equipment. Sign up for committees will take place each fall. New members will sign up upon acceptance into the club. Additionally, all members are expected to help with Spring and Fall clean up, including putting in and taking out the public dock.

2. Fundraising is needed to provide the club with the necessary financial resources to run our shows. As such, each skiing member must provide a minimum of \$150 net profit fundraising revenue to the ski club per year; there is an annual maximum cap of \$500 per family. One half must be collected by June 1st. The full amount must be collected by August 1st. Completion of required fundraising by these dates is required in order to continue participation in club functions including ski practices and shows. Our primary fundraisers are program book ad sales, company donations, and individual donations. Other fundraisers such as Brewers concessions, raffle ticket sales, etc...may be added at the discretion of the Board of Directors.

3. To become a member of the club or to renew your membership, the following must be completed annually prior to participating in any practice or show:
 - a. All skiing members must have completed their fundraising and work requirements for the prior year before a membership application can be considered.
 - b. Submit all membership forms including: Membership application, Emergency Form, and Skills Assessment Form to the Membership Director. Additionally signed USA Water Ski waivers for sanctioned shows and practices as well as for our club liability insurance must be submitted. These forms can be found on the Member page of our website:
 - c. Pay annual club dues, which are due by the February Member Meeting.
 - d. Have a current ACTIVE membership (not a "Supporting" membership) in USA Water Ski. To apply for a new membership please go here: <http://www.usawaterski.org/pages/Join.html> To renew your membership, please go here: <https://www.usawaterski.org/members/login/>
 - e. All applicants under the age of 14 must have a parent or legal guardian join PLWSC and obtain a USA Water Ski membership. Additionally it is expected that a parent or legal guardian will be in attendance at all shows and practices in which the member under the age of 14 participates.
